The purpose of this report is complete the external audit process for the financial year 2013/14.

No. DETAIL

I) INTRODUCTION

- a) The external audit is based on the Annual Return that includes headline figures from the Annual Accounts, the Report of the Internal Auditor and the Annual Governance Statement signed by the Mayor.
- b) The Town Council accepted the completed Annual Report and authorised the Mayor's signature in Minute 69/14 of its meeting of 19 May 2014.

2) COMPLETION

- a) The Annual Return was signed off by BDO Binder Hamlyn on 30 July and received back by us on 10 August.
- b) The External Auditor's Report is unqualified, stating: on the basis of our review, in our opinion the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.
- c) The Town Council's remaining responsibility is to ensure the public display of Sections 1 to 3 of the Annual Return for 14 days before 30 September 2013.
- d) A copy of the Annual Return is attached to this report for information.

3) MINOR ISSUES

- a) The Auditor has identified two minor issues for the Town Council to note.
- b) The Council have included grant monies received in box 2, rather than box 3, other receipts.
 - i) This refers to the inclusion of the Precept Support grant from the Isle of Wight Council as part of the Precept, ie included in the Annual Precept Box (2) rather than the grants box (3).
 - ii) This was done after discussion with the Town Council's Internal Auditor as there was widespread doubt among Town and Parish Councils about the best approach.
 - iii) The External Auditor's recommendation is that in following years only the actual Precept receipt is included in Box 2 and we will of course comply with that recommendation.
- c) The bank balance disclosed in box 8 excludes £51,050 which has been received on behalf of a local methodist church building which is used as a local boxing club.
 - i) The Auditor's recommendations in this matter are that if the funds are still held at the year end, they are included in the Annual Return and that advice is taken from the National Association of Local Councils (NALC) or the Society of Local Council Clerks as to whether the TownCouncil has the necessary powers to receive and return funds of this nature.
 - ii) The advice from the Society of Local Council Clerks, received on Tuesday 2 September is: the auditor seems to have missed the point that this is not 'Council' money at all. The auditor should not be involved, except in so far as there are any costs arising from running a separate Fund bank account, and those costs are likely to be very small and incidental.



Local Councils in England

Annual return for the year ended 31 March 2014

Local councils in England with an annual turnover of £6.5 million or less must complete an annual return in accordance with proper practices summarising their activities at the end of each financial year. In this annual return the term 'local council' includes a Parish Meeting, a Parish Council and a Town Council.

The annual return on pages 2 to 5 is made up of four sections:

- Sections 1 and 2 are completed by the person nominated by the local council.
- Section 3 is completed by the external auditor appointed by the Audit Commission.
- Section 4 is completed by the local council's internal audit provider.

Each council must approve this annual return no later than 30 June 2014.

Completing your annual return

Guidance notes, including a completion checklist, are provided on page 6 and at relevant points in the annual return.

Complete all sections highlighted in green. Do not leave any green box blank. Incomplete or incorrect returns require additional external audit work and may incur additional costs.

Send the annual return, together with your bank reconciliation as at 31 March 2014, an explanation of any significant year on year variances in the accounting statements and any additional information requested, to your external auditor by the due date.

Your external auditor will identify and ask for any additional documents needed for audit. Therefore, unless requested, do not send any original financial records to the external auditor.

Audited and certified annual returns will be returned to the local council for publication or public display of sections 1, 2 and 3. You must publish or display the audited annual return by 30 September 2014.

It should not be necessary for you to contact the external auditor or the Audit Commission directly for guidance.

Guidance notes on completing the 2013/14 annual return

- 1 You must apply proper practices for preparing this annual return. Proper practices are found in the Practitioners' Guide* which is updated from time to time and contains everything you should need to prepare successfully for your financial year-end and the subsequent audit. Both NALC and SLCC have helplines if you want to talk through any problem you encounter.
- 2 Make sure that your annual return is complete (i.e. no empty green boxes), and is properly signed and dated. Avoid making any amendments to the completed return. But, if this is unavoidable, make sure the amendments are drawn to the attention of and approved by the council, properly initialled and an explanation is provided to the external auditor. Annual returns containing unapproved or unexplained amendments will be returned unaudited and may incur additional costs.
- 3 Use the checklist provided below. Use a second pair of eyes, perhaps a council member or the Chair, to review your annual return for completeness before sending it to the external auditor.
- 4 Do not send the external auditor any information not specifically asked for. Doing so is not helpful. However, you must notify the external auditor of any change of Clerk, Responsible Finance Officer or Chair.
- Make sure that the copy of the bank reconciliation which you send to your external auditor with the annual return covers all your bank accounts. If your council holds any short-term investments, note their value on the bank reconciliation. The external auditor must be able to agree your bank reconciliation to Box 8 on the Accounting Statements (Section 1). You must provide an explanation for any difference between Box 7 and Box 8. More help on bank reconciliation is available in the Practitioners' Guide*.
- 6 Explain fully significant variances in the accounting statements on page 2. Do not just send in a copy of your detailed accounting records instead of this explanation. The external auditor wants to know that you understand the reasons for all variances. Include complete analysis to support your explanation. There are a number of examples provided in the Practitioners' Guide* to assist you.
- 7 If the external auditor has to review unsolicited information, or receives an incomplete bank reconciliation, or you do not fully explain variances, this may incur additional costs for which the auditor will make a charge.
