

TOWN COUNCIL MEETING

REPORT 85/14

13 OCTOBER 2014

The purpose of this paper is to ask Members to consider and respond to a proposal from the Isle of Wight Council's Strategic Manager Recreation, Leisure and Public Spaces for funding an additional Environment Officer post.

No. DETAIL

I) CONTEXT

- a) The request to Town and Parish Council's to consider jointly funding one Environment Officer post is included in the letter from the Isle of Council's Recreation, Leisure and Public Spaces Strategic Manager, Alex Minns following the decision of the Isle of Wight Council to cut the numbers of posts in the Environment Officer team from the current 7.5 to 3.5.
- b) A matrix attached to the letter shows the range of services by the team that will be lost when that happens.

2) PROPOSAL

- a) The matrix also shows those services due to be lost that could be retained if Town and Parish Councils agree to fund an additional post to increase the team's establishment to 4.5.
- b) The proposal is that this is funded by contributions of 40 pence per head of population for parishes with more than 5,000 people and 30 pence per head for those with fewer residents.
- c) The cost to Ventnor Town Council, shown on the matrix with a population of 5,976 would be £2,390.40pa

3) PUBLIC BUILDINGS WORKING GROUP

- a) The Public Buildings Working Group considered the proposal matter in more detail at its meeting of 7 October and noted the information supplied by the Isle of Wight Association of Local Councils (IWLAC) listing a number of town and parish councils that had already determined not to support it.
- b) It was agreed that the additional service available in the town would be both minimal and outside of the Town Council's control.

4) RECOMMENDATION

The Public Buildings Working Group recommends the Town Council not to support the proposal to part fund an additional Environment Officer post.
