The purpose of this paper is to record the candidates validly nominated to stand for election to Ventnor Town Council on 4 May 2017.

**No.    DETAIL**

---

**1)    BACKGROUND**

- a) Town and Parish Councils follow the same pattern as County Councils of four-year terms concurrently for all elected Members.
  - b) Elections were last held on 7 May 2013 and the Councils elected on that date complete their term of office on 8 May 2017.
  - c) Elections to replace them take place on 4 May 2017 along with those for the Isle of Wight County Council.

**2)    CANDIDATES**

- a) The deadline for nominations to stand for the elections to the Town Council's five wards was 4pm on 4 April and the lists of valid nominations received at that time were published later that day and have been posted to the Town Council's web site and the Central Car Park Noticeboard.
  - b) The notices for the Town Council Wards are attached to this Report.

**3)    ELECTIONS**

- a) Those nominated for the Bonchurch, Lowtherville, St Lawrence and Ventnor West are the same as or fewer than the number of Members representing them and, consequently, they will be declared as elected without the need for an actual election.
  - b) There are four nominations for the three Members to represent Ventnor East and, consequently, an election will take place on 4 May.
  - c) There will be two remaining vacancies – one each in Lowtherville and Ventnor West - after the completion of the election process.
