Welcome to edition 137of our Clerk's Column circulated as usual to the 490 residents on our Residents' Forum email list and through the Chronicle's page 4.

NOVEMBER FINANCIALS

At 30 November the balance of the Town Council's funds was £235,847. Expenditure during the month of November totalled £56,208 including Salisbury Gardens' costs of £3,428. The largest non-salary costs were the payment of £16,042 to the Isle of Wight Council for the Grounds Maintenance work at Ventnor Park and £2,814 for the annual Insurance of the Salisbury Gardens building.

Receipts during November came to £15,431 of which £9,068 came from Salisbury Gardens' rents.

The total spent on Precept funded items during the first eight months of the current financial year was £45,032 more than budgeted for while receipts in the same period were £12,960 above budget.

ASSETS & SERVICES WORKING GROUP

The Group's meeting on Tuesday morning opened with a decision to refer our new Esplanade signage pointing the way to the Public Toilets to the Isle of Wight Council following a complaint. We then agreed that the cost of installing a shower in our Green Road is too great to be affordable this year. Free parking in our Dudley Road, Market Street and Pound Lane car parks on Saturdays 3 and 10 December in support of local businesses was confirmed. We agreed the disputed clause in the lease of the four parking spaces in the Central Car Park for our new toilets.

PLANNING COMMITTEE MEETING

Of the seven applications on its Thursday Agenda the Committee supported9* six and saw no reason to object to the other one. Six members of the public attended the meeting's Public Forum to express concerns about the application for a revised location for the Time & Tide Bell. Their concerns included ongoing maintenance, upkeep, insurance, together with safety of the structure, including seasonal tides, wave heights, surrounding rocks within the vicinity and the possible noise level. The Committee supported the application but *requires further clarification on suitability regarding tide heights and storm surges that could affect the action of the Bell.*

COMMUNITY SUPPORT FUND IS OPEN ...

One week after its launch the Fund holds a total of £25,950. This Fund is in response to suggestions

from residents who saw our documentary *Family Voice* in which Ventnor residents without enough



income for life's basics spoke for themselves and their families. The film can be viewed <u>here</u>.

They praised the town's community organisations providing support: our Foodbank, Baby Box, and the Pantry with one adding *I've got faith in the Community*.

But with Christmas and Winter increasing demand the supporting organisations will need additional funding to meet it. That's what this Fund is for: if it reaches £40,000 by Christmas, the Foodbank, Baby Box and the Pantry will be able to have an additional £10,000 each and we'll be able to extend the Wellbeing Café's hours as well as providing another £5,000 of vouchers to the families on our voucher list facing the additional cost of no free school meals during the coming holiday.
