MINUTE SUBJECT

01/26 PUBLIC FORUM

There were no members of the public present.

02/26 APOLOGIES FOR ABSENCE

Apologies for absence from Cllr Steve Cooper were conveyed by the Chair.

03/26 DECLARATIONS OF INTEREST

Cllr Steve Milford declared an interest regarding agenda item 6, as Trustee of Baby Box who operate from the former Youth Centre.

04/26 MINUTES OF THE PREVIOUS MEETING

The Minutes of the meeting of 10 December 2025 - having been previously circulated to Members - were taken as read and approved.

05/26 ELECTRICAL INSTALLATION CERTIFICATE REPORTS

The Clerk updated members that the EICRs were booked in for the Esplanade toilets, Shore Road toilets, Central Car Park toilets, Boniface Fields, and the First Aid Hut. They would be completed during week commencing 16th March, with the results brought to the next committee meeting.

Members noted this update, with no decision required.

06/26 SALISBURY GARDENS

The Clerk updated members that measures to remove the precarious wood work on the West-facing side of Salisbury Gardens that had been completed, with any holes covered to avoid entrance by pigeons etc.

It was unanimously agreed that:

The Committee noted that these works were now complete.

07/26 VENTNOR CENTRAL/FORMER YOUTH CLUB

Members were updated on progress with discussions about the building with the Isle of Wight Council. The Clerk had attended a site visit on Tuesday with IWC officers to walk the scaffolding. The initial finding was that much of the stonework and associated masonry was in very poor condition. The indication was that the expenditure required to bring the building back into a usable state was likely in the tens-of-thousands of pounds.

The Isle of Wight Council had funded the scaffolding, and would re-establish access via the entrance on Victoria Street to enable the staff and volunteers of the charities occupying the hall to retrieve items from there as required.

Cllr Mark Jefferies informed the committee that it was unlikely that the Isle of Wight Council would be able to fund significant repairs.

Members noted that:

Alternative accommodation for the charities was actively being sought, that VTC had agreed to empty the lower ground floor of the building which was underway, and that the Clerk was attempting to negotiate a reduction in Business Rates for the time that the building was unusable.

08/26 EXCLUSION OF PUBLIC AND PRESS
